Russell Shrader presented the January 2014 Financial Report reflecting:

Beginning Balance......\$18,262.05 Deposits Equaling\$8,850.00 Expenditures Equaling.....\$9,781.75 Ending Balance....\$17,330.30

\$4,000.00 of the above noted Expenditures classified as a *Loan to 501 C (3)* was discussed and a proposal to designate the \$4,000.00 as a Grant to the Foundation was voted on and approved unanimously by acclamation at the January 30 2013 Noon Meeting.

At that time a check from the OCFSH General Fund for \$4,000 was written by OCFSH Treasurer Russell Shrader and immediately handed over to **FSOYF Treasurer Raymond Holmes for deposit into the Foundation bank account.

At this time in the meeting Treas Holmes confirmed that a bank account for the Foundation has been established with Frost Bank and \$4,000.00 check was deposited.

Pres Coleman called for a motion to convert the \$4,000.00 from a Loan to a Grant to the Foundation. Dean moved to approve; Fay seconded and the board approved the motion unanimously.

There still remain funds and expenses that need to be finalized between the FSOYF account and the OCFSH account. These matters will be taken up at the February 11th Executive Committee Meeting and will be resolved after the total Film Festival net revenue is tallied. Jack Kellmann made a motion to approve the Financial Report and seconded by Fay Hopkins. The motion was approved unanimously.

<u>Note</u>: As for these minutes and all future minutes the word <u>Foundation</u> recorded in the minutes will also mean <u>Ft Sam Optimist Youth Foundation</u>.

Seventeen days (17) 'til Showtime and tickets for the February 22 2014 Children's Film Festival are still available from Rick. We still haven't sold that many as of late. The festival
